Frederick & Mary Della Moss Archives & Special Collections Dallas Theological Seminary, 3909 Swiss Ave., Dallas, TX 75204 Historical Sketch: The Evangelical Theological College opened in 1924, and was renamed Dallas Theological Seminary in 1936. The school started in a rented building and moved to its current location on Swiss Avenue in 1926. Enrollment and the campus have grown through the years. The first extension site offered classes in 1987 and online courses started about 2005. One constant through the years has been the Bible-centered curriculum.

Seminary business was originally handled by a group of businessmen known as trustees. They delegated academic decisions to three people: Lewis Sperry Chafer, the registrar, and the vice-president. The school's bylaws changed in 1929 to establish one main board and two secondary boards. The Board of Trustees oversees financial policies. The Board of Regents handles academic and spiritual concerns. Together the members of these two boards and some at-large members form the Board of Incorporate Members (BIM), which is responsible for the general welfare and progress of the seminary. Members of the BIM serve for five years, but may be reappointed. The administrative structure changed in 1967 so the Business Manager reports to the president instead of the Board of Trustees. This simplifies the organization and makes it easier for the president to implement policies. The first women on the Board were appointed during Charles Swindoll's last year as president and began serving during Mark Bailey's term in 2001.
